Dan moved to appoint Emma Steel to be on the MLT until January 2024. Mary Hair seconded. Vote: All approved. Motion passed.

** Update on plan to invite more participation in church activities

Dianna Parks gave an update on ways her group is increasing participation in church activities.

- 1. Cindi, Larry, and Dianna met to discuss volunteer vacancies, especially among leadership roles.
- A. We are updating the new member interest forms
- B. Working with Pastor Dan to update new systems to operationalize the member interests
- C. Dianna will reach out to existing Chairs and gauge their interest in training new folks
- D. The MLT promised to help and encourage new leadership, offering gratitude and assistance, and not enumerating struggles and learning curves.

Dianna and Pastor Dan met to begin planning for a new member bonding series in the Mission House. Thinking is that during the pandemic it was difficult to be integrated into the full community and it might be hospitable to invite the new members to be new together.
